# 680-X-3-.03 <u>Time And Method Of Payment; Renewal And Non-Disciplinary Penalty For Late Renewal Of Controlled Substances Permit.</u>

- (1) Registration fees shall be paid at the time the application or renewal furnished by the Alabama State Board of Pharmacy for registration is submitted for filing. Payment shall be made payable to the Alabama State Board of Pharmacy and Pharmacy Board shall be due October 1 of each renewal cycle and delinquent after the last day of December of each renewal cycle. If the application for renewal and appropriate renewal fee is not received in the Board's office by December 31 of any renewal cycle but is received in the Board's office no later than January 31 of the following year, a one-time non-disciplinary administrative penalty of five hundred dollars (\$500.00) fifty percent (50%) of the prevailing renewal fee must be paid. by-January 31 of the following year in order to renew. This penalty shall be in addition to the prevailing renewal fee. Any subsequent instance of late renewal shall result in disciplinary action.
- (2) This Rule is adopted pursuant to the Board's authority set forth in <u>Code of Ala. 1975</u>, §34-23-33(b) and is in lieu of formal disciplinary proceedings.
