

ALABAMA BOARD OF PHARMACY
HEARING MINUTES
April 15, 2025

President Gary Mount called the April 15, 2025, hearing session of the Alabama Board of Pharmacy to order at 8:24 a.m. to hear cases and review applicant appearances and determined a quorum was present. 1. HEARINGS

The following case numbers were heard by the Board beginning at 8:25 a.m. and ending at 8:41 a.m.: 22-0062, 23-0243, and 22-0208. Board member Tommy Cobb recused himself from hearing and deliberating case number 23-0243.

2. HEARING MINUTES

A motion to approve the March 25, 2025, hearing minutes was made by Dr. Cobb and seconded by Ms. Giles. A vote was taken and the motion passed unanimously. No nays or abstentions recorded.

3. CASE CORRECTION MOTION

During March 25, 2025, hearings, case number 25-L-0043 was read into the record as 25-L-0034. A motion was made in the correct case number, 25-L-0043, to send to attorney for legal review by Dr. Cobb and seconded by Mr. Brooklere. A vote was taken and the motion passed unanimously. No nays or abstentions recorded.

4. DISCUSSION

A brief discussion was held regarding the position of executive secretary and requirements for discussing the matter.

5. EXECUTIVE SESSION

A motion was made by Mr. Brooklere to go into executive session for the purpose of deliberating cases heard today. Ms. Neumann certified as an officer of the court and a member in good standing with the Alabama State Bar that the purpose for this executive session is to deliberate on the three cases previously heard today. A voice vote was taken and the motion passed unanimously. No nays or abstentions recorded. The executive session will begin at 9:00 a.m. and the Board will return at 9:15 a.m. The hearing was recessed at 8:55 a.m. and the public meeting resumed at 10:05 a.m.

7. EXECUTIVE SESSION

A motion was made by Dr. Cobb and seconded by Mr. Brooklere to go into executive session for the five Board members to discuss qualifications of individuals to be licensed by the Board. Ms. Neumann certified as an officer of the court and a member in good standing with the Alabama State Bar that the purpose for this executive session is to discuss qualifications of individuals to be licensed by the Board. A voice vote was taken and the motion passed unanimously. No nays or abstentions recorded. The executive session will begin at 11:15 a.m. and the Board will return at 11:30 a.m. The hearing was recessed at 11:04 a.m. and the public meeting resumed at 12:32 p.m.

8. MOTIONS ON APPEARANCES AND CASES

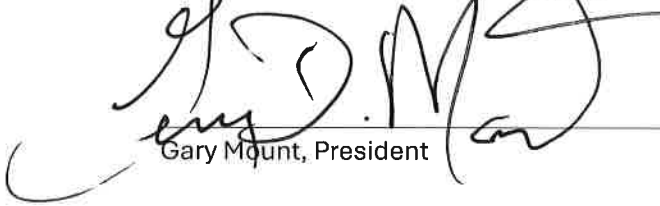

A vote was taken and the motion to withdraw passed with aye votes from Dr. Mount, Dr. Cobb, Mr. Brooklere, and Dr. Hicks. No nays or abstentions recorded.

A motion was made by Dr. Cobb and seconded by Ms. Giles to grant the applications in case numbers 24-L-0171, GNCI-9QCPSD, and EQ52-DQZY79. A vote was taken and the motion to grant passed with aye votes from Dr. Mount, Dr. Cobb, Mr. Brooklere, and Dr. Hicks. No nays or abstentions recorded.

Dr. Mount expressed his thanks to Dr. Susan Alverson for her work as interim executive secretary. Dr. Mount then called for nominations for interim executive secretary due to Dr. Alverson's recent resignation. Dr. Cobb nominated Casey Shaw as interim executive secretary. No additional nominations were made. A motion to appoint Casey Shaw as interim executive secretary was made by Mr. Brooklere and seconded by Dr. Cobb and Dr. Hicks. A vote was taken and the motion to appoint Casey Shaw as interim executive secretary passed unanimously. Dr. Mount then took an individual voice vote, which was also unanimous. No nays or abstentions recorded.
