6. MOTIONS ON APPEARANCES



A motion was made by Dr. Cobb and seconded by Dr. Hicks in case numbers 25-0280 and 25-0265 to deny the request for virtual appearance. A vote was taken and the motion to deny the request for virtual appearance passed with aye votes from Dr. Mount, Dr. Cobb, and Dr. Hicks. Ms. Giles and Mr. Brooklere voted nay. No abstentions recorded.
